CONSENT ORDER

To facilitate a conclusion to the allegations against Lucille Daigle, LPN, the Louisiana State Board of Practical Nurse Examiners does hereby offer this consent order. The allegations include:

It came to the attention of the board that the respondent falsified her 2013 renewal application. The respondent indicated on her 2013 renewal application that she was employed as an LPN full-time at Center for Neurosurgery from 11/1/2012 to 6/6/2013. Upon verification of her employment, it was noted that she was employed as a medical office assistant/office tech.

Based on the evidence submitted, the board has concluded that **Ms. Daigle** is in violation of the following provisions of Louisiana Revised Statutes, Title 37, Chapter 11. Nurses, Part II. Practical Nurses, Section 969 A. 4. **(a) is guilty of fraud or deceit in procuring or attempting to procure a license to practice practical nursing; (f) is guilty of unprofessional conduct; (g) has violated any provisions of this Part; and §978. A. (8) Violate any provisions of this Part.**

As further defined in the Louisiana Administrative Code, Title 46, Part XLVII. Nurses, Subpart 1, Practical Nurses, Section 306.T.

- 1. **being guilty of fraud or deceit in procuring or attempting to procure a license to practice practical nursing;**
- 8. **being guilty of unprofessional conduct;**

 - i. **falsifying records;**
 - t. **violating any provisions of R.S. 37:961 et seq. (the practical nursing practice act), as amended or aiding or abetting therein.**
