



CONSENT AGREEMENT/ORDER


The Louisiana State Board of Practical Nurse Examiners does hereby offer this consent agreement/order to **Danielle Hack, license #20100268**, based on the following:

FINDINGS OF FACTS

1. The board received the respondent's 2016 renewal application in which she answered "yes" to question #18.a. on her application which asks: SINCE YOUR LAST RENEWAL, HAVE YOU: Been arrested, charged, convicted of, plead guilty, or no contest and/or nolo contendere or been sentenced for any criminal offense in any state? (NOTE: even though an arrest or conviction has been pardoned, EXPUNGED, dismissed or deferred and your civil rights have been restored, you must answer "YES" and attach a detailed written statement and certified copies of the criminal record(s)).
2. The respondent submitted a narrative statement and court documents regarding a shoplifting arrest that occurred in 2002. According to the court documents, the respondent was charged with theft of goods (under \$50) on 1/11/2002. She was placed in a diversion program and the charge was dismissed on 5/23/2003.
3. Review of the respondent's records with the board indicates that she failed to disclose this arrest when she enrolled in the nursing program. The respondent completed and signed her admission form on 5/21/2008. She also completed and signed her First Time Writers Application on 12/9/2009. The respondent failed to report her 1/11/2002 arrest on both applications.

CONCLUSIONS OF LAW

Based on the evidence submitted, the board has concluded that **Ms. Hack** is in violation of the following provisions of Louisiana Revised Statutes, Title 37, Chapter 11. Nurses, Part II. Practical Nurses, Section 969 A. (4):

- (a) **is guilty of fraud or deceit in procuring or attempting to procure a license to practice practical nursing;**
- (f) **is guilty of unprofessional conduct;**
- (g) **has violated any provisions of this Part; and**

§978 A. (8) Violate any provisions of this Part; and B.


As further defined in the Louisiana Administrative Code, Title 46, Part XLVII. Nurses, Subpart 1, Practical Nurses, Section 306:

- 1. **being guilty of fraud or deceit in procuring or attempting to procure a license to practice practical nursing;**
- 8. **being guilty of unprofessional conduct;**
 - i. **falsifying records;**
 - t. **violating any provisions of R.S. 37:961 et seq. (the practical nursing practice act), as amended or aiding or abetting therein.**

In lieu of a formal hearing on the matter, the respondent consents to accept and abide by the following orders of the board:

- 1. The respondent shall be issued a letter of reprimand as disciplinary action against the respondent's license for the violations of the Nurse Practice Act.
- 2. The respondent is hereby fined **\$250.00** for the violations of the Nurse Practice Act, payable by **cashier's check or money order only**, due within **ninety (90) days** from the date of this order.


The respondent is hereby notified and by signature *Danielle Hack*






I understand that this agreement is effective immediately upon signature of the executive director and will become an order of the board. It is understood that this agreement does not preclude the Board of Practical Nurse Examiners from requiring a formal hearing of my case. I further understand that should this agreement not be accepted by the board, I agree that presentation to and consideration of this agreement, the documenting evidence and information obtained by the board shall not unfairly or illegally prejudice the board or any of its members from participation in hearings or other proceedings pertaining to these or other matters.

I further agree that if at any point during the execution of this agreement, I violate the stipulations set forth, my license will be suspended. In order for my license to be reinstated, I must demonstrate, to the satisfaction of the board that I pose no danger to the practice of nursing or to the public and that I can safely and competently perform the duties of a practical nurse. The board, in reinstating my license, will require a period of probation, along with supportive conditions or stipulations as outlined in this agreement to ensure that patients and the public are protected.




