RE: LICENSE REVOCATION

Dear Ms. De St. Germain:

Your license to practice as a licensed practical nurse in the State of Louisiana is hereby immediately revoked for violating your Board Order. Please refer to the Violation Section of your Board Order, copy enclosed.

According to the stipulations of your Board Order, you are in violation of the following stipulations:

- #2. - **Obey All Laws:**
 - A. The respondent shall obey all laws/rules governing the practice of practical nursing in this state and obey all federal, state, and local criminal laws.
 - B. The respondent shall report to the Board, within ten (10) days, any misdemeanor or felony arrest or conviction.

It was reported to the board that you were arrested January, 2016 for the charge of possession with intent to distribute Alprazolam, (Xanax), possession of drug paraphernalia, marijuana and Suboxone, thus you violated stipulations #2.

- #4. - **Obtain an Evaluation for Chemical Dependency:** to date, you have not provided this information to the board as required.
- #6. - **Select One Primary Pharmacy:**
 - A. The respondent must notify the Board of the name, address, and telephone number of his/her selected pharmacy within ten (10) days of the date of the Board order. If the respondent acquires a new pharmacy, written notification must be received within ten (10) days of the first use.

• **#8. - Enroll in a Drug Screening Program:**

- A. Within ten (10) days of the date of this order, the respondent shall register with a drug screening firm selected by the Board. Drug screens will begin immediately upon registration with the drug screening firm.

To date, you have failed to enroll in the drug screen program.

• **#10. - Fines/Fees:**

A. The respondent is hereby fined \$500.00, **payable by cashiers check or money order only**, for the violations detailed in the Conclusions of Law and payable within 90 days of the date of this order.

B. The respondent must pay any/all fines/fees owed to the Board, including a reinstatement fee, if/when applicable. Fines/fees are **payable by cashiers check or money order only.**

To date, you have failed to pay the fines/fees assessed.

You may no longer practice practical nursing in Louisiana as of the date of this letter. You are to immediately return your current practical nursing license to the board office. Failure to return your license and continuing to work while your license is revoked will be reported to the appropriate agencies.

As stated in your consent agreement/board order the following violations apply if you do not comply with the mandated stipulations:

VIOLATIONS

Failure to comply with any and/or all sections of this order may result in any and/or all of the following: a) immediate suspension of license, b) indefinite suspension of license, c) ineligibility for annual renewal of license, d) additional fines/penalties up to \$500.00 per occurrence, e) increased probationary period, f) summary suspension, and/or g) revocation.
